Minutes

The Presbytery of St. Andrew met in a hybrid format, both in-person and virtually via Zoom, for its Winter Stated Meeting and Annual Meeting of the Corporation at 10:00 a.m. on Tuesday, March 7, 2023, at Leland Presbyterian Church of Leland, MS, with the moderator in the chair and the stated clerk present.

The meeting began with a service of worship with a sermon by outgoing moderator Elder Kevin Magee. The Rev. Deb de Boer served as liturgist. The service included the installation of the Rev. Buren Blankenship as Moderator for 2023-24.

Organization of the Meeting

Following worship, Moderator Blankenship opened the meeting with prayer. He then appointed the Rev. Barrett Milner and Ruling Elder Murphy Jones as the Committee on Thanks.

Visitors and first-time commissioners were welcomed to the meeting and introduced to the council.

Roll of the Meeting

The Stated Clerk was recognized, and reported that there were 23 minister members (13 in person and 10 via Zoom) and 14 ruling elder commissioners (6 in person and 8 via Zoom) present at the meeting, plus 8 ruling elders (5 in person and 3 via Zoom) enrolled for terms of service, for a total of 4 5voting members. Kevin Magee gave a brief report regarding an adjourned meeting for the constitutional amendments that has been established for March 21 via Zoom at 10:00 a.m. to complete any unfinished voting at this meeting. He noted the following items for information:

- 1. The Administrative Board has reviewed the reports of the Presbytery's Committees, and commends their recommendations to the Presbytery for its consideration as they are contained in this packet.
- 2. The Administrative Board has approved minutes of the Presbytery's Fall Stated Meeting on October 4, 2022, which will be available soon for review on the presbytery's website.
- 3. Amendments to Camp Hopewell's 2023 budget which was adopted last fall were approved as included in the Camps and Conferences Committee's report.
- 4. Hunger Action Grants were approved as contained in the report of the Missions Committee.
- 5. An adjourned meeting of the Presbytery was set for 10:00 a.m. on Tuesday, March 21, 2023 to complete this meeting's business in the event that it cannot be completed today. This meeting will be held electronically via Zoom.
- 6. The Administrative Board authorized a \$5,000 donation from Camp Hopewell's Capital Improvements Designated Fund to Living Waters for the World's construction project – a \$50,000 total project that is adding a new pavilion next to the water building on the back side of the lake. The donation is designated for the road improvements that are necessary before the

building work can begin, which is in keeping with the Presbytery's License Agreement with LWW, in which road maintenance is listed as the Presbytery's responsibility.

Missions

Allison Wehrung, Associate Presbytery Exexucitve, was recognized to report for the Missions on behalf of Ron McDougald, moderator. She presented the following 2023 Hunger Grants for \$800 for 13 organizations that have been approved by the Administrative Board:

She noted that historically each organization has been awarded \$1000, but for the first time in recent memory there were more grant applications than available funds to do so. The grants are supported by the presbytery's Centsability Fund, and you or your congregation can contribute by mailing donations to the presbytery office or giving online at standrewpresbytery.org/events-missions/donate/.

She then reported the following additional items for information:

- The Leta Arnold Fund is being put to use in Cameroon at a vocational school that is up and running.
- Living Waters for the World is making use of hybrid/virtual training, which allows participants to learn from partners around the world. A leadership retreat is coming up at Camp Hopewell later in February, for both previous Clean Water U participants and other LWW stakeholders, and fundraising for a new pavilion out near the water buildings at Camp Hopewell is underway. LWW's first water partnership in Liberia is in the works.
- Matthew 25 Check-ins continue on Zoom, on second Tuesdays from 12:15-1pm. Anyone is welcome to attend regardless of what role they play in their congregation or where their congregation is in considering/becoming a Matthew 25 church. The conversation usually ranges from sharing events churches are already working on to asking questions and brainstorming new ideas.
- The committee has agreed to partner with the Education, Worship, and Nurture Committee on a civil rights centered educational event. The partnership is still in the early brainstorming stages, but is likely to include a visit to an important site(s) in the region and the opportunity for conversation around that visit.

She then introduced Nancy King, Director of the Leland Food Pantry, to speak about the work of that organization.

Evangelism and Church Development

Jerry Long was then recognized for the report of the Evangelism and Church Development Committee. He reported on the success of the Small Church Gathering that took place in Batesville at the Independence Presbyterian Church on October 22, 2022 everyone in a small church (75 members or less) to attend. Fall of 2024 for the next one.

He then spoke about Synod Technology Grants available through his committee, noting that the form for new grants is now online, that 11 grants have been awarded to date, and that funds are still available and churches are encouraged to apply.

He then called on Rev. Frank Beck, Pastor of Senatobia Presbyterian Church, to report on the result of the Technology Grant for his church. Rev. Jody Hill of Ripley Presbyterian Church also spoke about how much the Tech Grant has improved that church's online and streaming service.

Moderator Long then reported the following additional items for information:

- The ECD Committee reviewed evaluation forms from the Small Church Gathering held on October 22, 2022 at Independence Presbyterian in Batesville. Overall, the evaluations were very positive. Participants expressed appreciation for all the sessions offered, and noted that the Mental Health presentation was a timely and especially important topic for our churches.
- ECD discussed ideas for presentations and workshop topics at future Small Church Gatherings. The committee agreed to survey small churches in the future about topics that would be the most helpful for them. In addition, ECD will survey presbytery to determine if there are any individuals who would like to present a small church-related topic themselves at the next event.
- Committee discussed a potential time and date for the next Small Church Gathering. Based on input from the evaluation form, the general consensus is to offer the event every other year in the Fall. As a result, ECD agreed to plan for another Small Church Gathering in the Fall of 2024.
- Committee members reviewed the Technology Grants issued to date to 11 churches at a cost of \$12,000. These churches include: Sumner (2 grants), FPC Grenada, Trinity Starkville, Senatobia, FPC Amory, Starkville, FPC Saltillo, Ripley, St. James, Bethel, Olive Branch.
- ECD members discussed the next steps for distributing the remaining \$12,000 in the budget. The committee brainstormed ways for checking in with our small churches and continuing to spread the word about the technology grants.
- Committee members agreed to let the grant recipients "tell their stories" about how their churches have used the funds to enhance the communications and technology within the church. The stories can be told at Presbytery meetings as well as through presbytery email blasts and mailings to those churches who do not have email access.

Evaluations Committee

Charles Bryson reported that the 2022 Entity Review process is complete, and the committee has met to review the completed online submissions. The committee has no recommendations at this time.

The Presbytery then recessed for lunch at 12:21 p.m. with prayer for the meal by Rev. Ann Kelly, after which it returned at 1:30 p.m. to continue its work.

Education, Worship and Nurture

Martha Knichel was recognized and reported the following items for information:

- UKirk Ole Miss continues to meet weekly on Tuesday nights, with occasional other gatherings. Other campus ministries in the presbytery are all currently on hiatus, primarily due to leadership transitions/departures.
- UKirk Ole Miss attended College Conference at Montreat in January and shared a house with UKirk Memphis. Any college students from the presbytery are welcome to join this trip, which is always January 2-5. Interested people should contact Allison Wehrung.

- The UKirk national network has released a free resource called "Why Are Presbyterians Like That?," which is a Bible study and discussion series about the basics of Presbyterian beliefs. There are two different versions:

 - For College Students: https://tinyurl.com/yckwcffx
- This year's retreat, Gather Around, is scheduled for March 24-26, 2023 and registration is open. The deadline to sign up is March 10.
- Changes in advisors: Melissa McDuffie (Tupelo) has come on to replace Allyson Ashmore. Robert Hall will be stepping down in the new program year and Lindsay Fournier (Hopewell Program Director) will replace him.
- PYC nominations for the 2023-2024 year will be open soon. Youth who will be in 10th-12th grade in the 2023-24 school year are welcome to apply, and the forms will be available on the PYC page of the presbytery's website.
- The continuing education event with Dr. Doug Ottati in November was a success, with about 14 people attending.
- EWN is beginning conversation with the Missions Committee to partner on a continuing education event (open to all) featuring a visit and conversation around a civil rights site(s) in the region. Planning is still in the early brainstorming stage, but details will be shared as soon as they are available.

Camps and Conferences

Nancy Bryson was recognized to report for the Camps and Conferences Committee. She noted that registration up to 56% for summer camp as of now. She then reported the following items for information:

Financial Report:

Recent building renovations have been paid for from the Capital Improvements Fund, which includes donations, a special disbursement from the endowment fund and income from the sale of property on the south side of the levee (both of which were approved by the presbytery in the fall). The fund currently has a balance of -\$36,075.57, which will be addressed in the course of 2023.

The Employee Retention Credit saved us in 2022 (line 411.04). 2022 was a hard year to budget for because we were coming out of COVID and unsure of how that would affect attendance and retreat business. The proposed revised budget reflects the hiring of a hiring of a part-time registrar, a decrease in salaries since no Executive Director has been hired at this time, and an increase in office expenses because of the telephone and internet bill increase. The Proposed Budget for 2023 has been revised to reflect the year-end figures.

The Administrative Board approved of the 2023 Revised Budget.

Facilities Update:

O'Dell Hall deck has been renovated and insulation added to winterize the building. Repairs were made to the dining hall, laundry building, McCorkle and the pool house due to frozen pipes during December 2022.

Robert is rebuilding and repairing several challenge course elements.

Camp Update:

Registration has opened are we are at currently at 51.5% (as of 2/14/23).

Tiered pricing was added to Day Camp this year and 60% have selected Tier 2 or Tier 3.

We have a new registrar, Elissa Rayburn, who is working part-time during the semesters and will be full-time during the summer.

Retreat business is steady and bookings are coming in for the year.

Executive Director Search Committee Update

The job description has been posted in several locations. With camp season approaching, an alternative plan is in progress in the likelihood that no director is in place by May. Nancy Bryson and Melissa McDuffie volunteered to serve with Greg Goodwiller as staff.

Administration and Stewardship

Vicki Schramm was then recognized for the report of the Administration and Stewardship Committee. She asked Greg Goodwiller to make the report as she was having sound issues. He stated that financial reports of the Presbytery of St. Andrew and Camp Hopewell through year-end, 2022 have been reviewed by the committee and filed for audit.

They were presented for review by the presbytery and are included in these minutes as an Attachment.

Reports from Commissioners to Synod of Living Waters

Rev. Ann Laird Jones and Elder Hardie Frankel spoke about their experiences at the annual Synod meeting in January 23, 2023 in Nashville, TN.

Report of the Permanent Judicial Commission

Trey Byars presented the proposed amendments to the constitution, some of which were adopted in a single vote by unanimous consent, with others voted on individually. The report of the presbytery's voting results are included as an attachment to these minutes.

The Stated Clerk reported that as all amendment voting has been completed, the adjourned meeting announced at the beginning of the meeting will not be necessary.

Rev. Barrett Milner and Elder Murphy Jones were then recognized for the report of the Committee on Thanks. They spoke about their gratefulness and joy for the hospitality, worship, and work of the council, including the honorable retirements of two long standing members, and wished everyone safe travels.

The meeting was adjourned with prayer by Ann Laird Jones at 2:52 p.m.
