Minutes

The Presbytery of St. Andrew met in a hybrid format, both in person and virtually via Zoom for its Fall Stated Meeting at 10:00 a.m. on Tuesday, October 3, 2023 at Hopewell Presbyterian Church, Oxford, MS, with the Stated Clerk present. The moderator was unable to be present, and so in accordance with the rules the meeting was moderated by the most recent past moderator able to attend the meeting, the Rev. Wil Howie.

The meeting began with a service of worship that included the Sacrament of the Lord's Supper and the annual necrology of presbyters from the Presbytery of St. Andrew who had died in the last twelve months. Rev. Andy Spaulding delivered a sermon entitled "What a Fellowship."

Ruling Elders remembered in the service were as follows:

Following worship, Moderator Howie opened the meeting with prayer. He then appointed the Rev. B.J. Chain and Elder Nancy Bryson as the Committee on Thanks.

Visitors and first-time commissioners were introduced to the council and welcomed to the meeting.

The Stated Clerk was recognized, and reported that there were 19 Teaching Elder Members, and 13 Ruling Elder Commissioners present at the meeting, plus 5 Ruling Elders enrolled for terms of service, for a total of 37 voting members. Also present were 3 Corresponding Members with voice but not vote, and an additional 9 visitors and staff for a total enrollment of 49. He moved that these be established as the roll for the meeting, and that requested excused absences be granted as noted in the Roll of the Meeting below. The motion was adopted by unanimous consent.

The Stated Clerk then presented the Special rules of Order for the meeting and moved that they be adopted as included in the meeting packet. The motion was adopted by unanimous consent.

He then presented the docket for the meeting which was approved by raised hand vote.

In his role as Secretary of the Corporation, Greg Goodwiller reported that the Trustees of the Presbytery of St. Andrew held their annual meeting at 9:00 a.m. on June 1, 2023 electronically via Zoom. Ruling Elder Trey Byars was re-elected President, and the Rev. Jerry Long was re-elected Vice-President, noting that the Executive Presbyter serves as Secretary of the Corporation in accordance with the Manual of Administrative Operations.

He then reported that a quitclaim deed for the former Westminster Presbyterian Church in Tippah County was approved and has been executed deeding that property to the Westminster Community Church and Cemetery, which will care for the property in perpetuity, and that a warranty deed for the

Booneville Presbyterian Church property was approved via email vote, and has been executed. The property was sold to SOWDKA, LLC for \$118,000.

He then moved on behalf of the Trustees that in accordance with G-4.0206a of the *Book of Order*, Independence Community Presbyterian Church, USA (Batesville) be granted presbytery's permission to acquire the cemetery of the of non-existent church formerly located on or near Parcel No. FR PF SE4 PF NE 4 SEC 12 T-10-R-8.

The motion was adopted by raised hand vote.

Allison Whitten Ashmore, Presbyterian Women Moderator, reported on the 2023 AL/MS gathering which took place in July, 2023 at Spring Hill Presbyterian Church in Mobile, AL, and on the Fall Cluster meetings, noting that the Beta/Gamma cluster meeting raised \$810 for Presbyterian Disaster Relief.

In the absence of the Administrative Board's moderator, Greg Goodwiller reported the following items for information:

- 1. The Administrative Board has reviewed the reports of the Presbytery's Committees, and commends their recommendations to the Presbytery for its consideration as they are contained in this packet.
- 2. The Administrative Board has approved minutes of the Presbytery's Winter Stated Meeting on March 7, 2023, and its called meeting on May 30, 2023, which will be available soon for review on the presbytery's website.
- 3. Camp Hopewell's 2024 proposed budget was adopted as included in the Camps and Conferences Committee's report.
- 4. The Board acted to remove Allyson Ashmore, former Camp Hopewell Director as a signatory on the Presbytery and Camp Hopewell checking accounts and add David Mills, its new Executive Director.
- 5. At the request of the Executive Presbyter, the Board authorized Kevin Magee, Administrative Board Moderator; Buren Blankenship, Presbytery Moderator; and Greg Goodwiller, Executive Presbyter and Stated Clerk to appoint a Special Committee to lead the presbytery in communal conversation and discernment around issues of human sexuality, same sex marriage, and gender identity.
- B.J. Chain was recognized for the report of the Commission on Preparation for ministry. He reported for information that the Commission has enrolled Betsy Beasley as an Inquirer, having been interviewed by the Commission regarding her Christian faith, her call to explore ministry as a vocation, and her plans to complete her seminary studies at Memphis Theological Seminary. Betsy is a ruling elder at Providence Presbyterian Church, Southaven, where she has been a member since 2017. She holds degrees from Mississippi State and Belhaven Universities.

Jody Hill was then recognized for the report of the Nominations and Representation Committee. He first noted that this is the meeting at which commissioners and a delegate to the General Assembly should be elected; however, sessions were not notified of the need for nominees in time for that to occur. On behalf of the committee, he therefore moved to suspend the rules and conduct those elections at an electronic called meeting sometime in early November. The motion was adopted by raised hand vote.

He then placed the following names in nomination for roles and terms as listed below, noting that only those names in *bold*, *italic* typeface are being elected at this meeting and that those names with an asterisk require suspending the rules. There were no nominations from the floor and the nominees were elected by raised hand vote with no negative votes.

Standing Committee reports were then given as noted below by their moderators or moderator's appointees:

Missions

Ruling Elder Ron McDougald via Zoom reported items for information:
-Monthly Matthew 25 'Check In' Meeting will continue, but a poll will be sent out to see what time

- would work best moving forward.
- -Living Waters for the World: In the last 20 years over 2500 have been trained through Clean Water U events. There are currently 1100 'Partners' in 28 countries. LWW is adapted to local conditions, including using local volunteers in Haiti, because of the current political/social upheaval. Water systems can be purchased and delivered for about \$4,000.
- -The Hunger Action Grants application will be available in early November. As of 8/31 there is just over \$4700 available, which is not enough to cover the typical number of applicants, so more contributions to the presbytery's Centsability fund are needed. The committee will be reaching out to churches to encourage participation. If congregations would like someone to come speak with their church about the grants, they can contact Ron Wilson or Allison Wehrung to be connected with an available committee member.
- -FPC, Oxford will be hosting the documentary film, "At the River" on Wednesday, November 29th at FPC. The documentary features Presbyterian pastors who spoke out against racism during the Civil Rights movement. The producer/director for this documentary, Carolyn Crowder will be present for a discussion of the film. The Missions Committee is co-sponsoring and all are welcome to attend.

Bob Sharman moved that the council view the trailer to the film when it reconvenes after lunch. The motion was seconded and adopted by voice vote.

Evangelism and Church Development Committee

- 1. ECD members discussed next steps for creating interest among smaller churches in the Technology Grants since \$12,000 is still available in the fund and no new grant requests have been received in the last quarter. In an effort to generate greater awareness among those churches who have not yet applied, the committee agreed to collect and promote stories from recipient churches about how they have used the funds. The stories should demonstrate how the grant has made a difference in the communication and technology within the church rather than simply listing the items that were purchased.
- 2. The committee also agreed to explore the availability of digital and training resources that the Presbytery could purchase and share with our smaller churches to assist them in learning more about technology and the use of the equipment. Committee will also look at the possibility of a link on the Presbytery website that would direct our smaller churches to basic instructional videos on YouTube.
- 3. Based on the results of the Small Church Gathering (SCG) survey from our 2022 event, ECD Committee members agreed to schedule another SCG in October 2024. The date and times are pending based on the 2024 football schedule. Independence Presbyterian is willing to serve as the host location again in 2024 unless another church expresses interest in hosting the event following an announcement at the October Presbytery Meeting. The Committee will explore ideas for speakers, workshops, and potential new sessions at its next meeting on January 25, 2024.

Evaluation

Charles Bryson reported that the Committee met via the hybrid format at 1:30 p.m. on Thursday, August 31, 2023. Members reviewed a list of Revised *Book of Order* provisions allowing or requiring new rules and policies that will result in amendments to the Presbytery's *Manual of Administrative Operations*. They also considered the 2023 annual review process for committee and commission members. With exception of the first item on the list of Revised *Book of Order* provisions and allowing/requiring rules or policies (G-3.0105), the Evaluation Committee decided to work on the rest of the new additions for presentation at the March 2024 Presbytery meeting. Some of these *Revised Book of Order* provisions and allowing/requiring rules for policies (G-3.0106, G-3.0303) will be addressed by the Commission on Ministry. The committee voted to suspend the 2023 Annual Survey and request committee members and officers provide input or suggestions directly to Evaluation Committee Moderator by December 15. 2023.

He then moved on behalf of the Committee that the word "Honorably" be deleted in the Presbytery *Manual of Administrative Operations* in sections 2.02.20, 2.06.10, 2.08.60D, and 3.06.30 per the result of such changes in the *Book of Order*. The motion was adopted by raised hand vote.

He then moved on behalf of the Committee and at the request of the Nominations and Representation Committee, that section 3.06.30 be amended as follows (additions in **bold**, **italics** and deletions in **bold**, **italics**):

Points are tabulated for any calendar year of service within Presbytery. If there is a point tie, the earliest date of enrollment into the Presbytery will determine the priority of the two commissioners. A Teaching Elder *must have been shall* be a member of the Presbytery of St. Andrew for at least two years before being eligible to be nominated. *Members at large and Retired all-All* Teaching Elders shall be eligible for consideration for nomination, provided that they maintain residence within the bounds of the presbytery and activity within its life including attendance at a minimum of *two one* presbytery meetings—per year. Points are returned to zero after service as a Teaching Elder commissioner. If the Teaching Elder with the highest point count either declines to be nominated or is not elected to serve for two consecutive elections, then their point count returns to zero.

Finally, in response to the new wording of G-3.0105 suggesting that councils adopt special rules of order and standing rules to govern electronic meetings, he moved on behalf of the Committee that the *Manual of Administrative Operations* be amended by inserting "**Special Rules of Order** For a Hybrid Meeting (in person or electronically via Zoom)" as new section 2.12.00. The motion was adopted by raised hand vote.

Education, Worship and Nurture

- The annual retreat is scheduled for February 23-25, 2024 and as usual will be open to youth in grades 6-12. More details will be available on the presbytery's website as they develop, and registration will open in early December.

Continuing Education

The committee is co-sponsoring with FPC Oxford a screening of *At the River*, a documentary by Carolyn Crowder about Presbyterian ministers in the South during the Civil Rights movement. All are welcome to attend on Wednesday, November 29 at 5:30pm at FPC Oxford.

Camps & Conferences

Nancy Bryson reported the following items for information:

- 1. Summer camp was a success with 381 total campers. 74 campers came from 11 churches in our presbytery.
- 2. A NVF Grant for Diabetes Camp was obtained again this year to host 41 campers. These funds were for camper scholarships at the Tier III level (full cost of a camper), supplies, food bills, and staff training/t-shirts for the Diabetes Camps.
- 3. Through the Angel Tree Program (part of the Salvation Army), we were able to host 11 campers for a 100% scholarship to camp. This is a ministry of the Prison Fellowship Ministries for children of incarcerated parents.
- 4. The financial reports are for January August 2023 and we are in the red. We had fewer summer campers due to smaller number of staff than usual. Also, fewer rentals.
- 5. Administration & Stewardship Report

Vicki Schramm reported on the following items for information:

1. Financial reports of the Presbytery of St. Andrew and Camp Hopewell through August 31, 2023, have been reviewed by the committee and filed for audit. They are presented here for review by the presbytery.

- 2. Camp Hopewell's 2024 Proposed Budget was endorsed by the Committee, as adopted by the Administrative Board.
- 3. Per capita assessments from the General Assembly, Synod of Living Waters, and the Presbytery of St. Andrew for 2023 are below. Congregations will be assessed these amounts based on each session's reported membership as of December 31, 2021:

General Assembly: \$9.80 Synod of Living Waters: \$3.98 Presbytery of St. Andrew \$4.99 \$18.77

She then moved the following motions on behalf of the Committee, each of which was approved by a raised hand vote.:

- 1. that a one-time distribution from the Hopewell Endowment Fund in the amount of \$45,539.45 be authorized to pay off the current deficit in the Capital Improvements fund as a result of additional costs related to completing the 2022 renovations.
- 2. That the Presbytery per capita assessment for 2024 be increased from \$4.94 to \$4.99, resulting in a total per capita assessment that is unchanged from 2023 due to a \$0.05 decrease in the General Assembly's 2024 assessment.
- 3. That a distribution of \$43,300 be authorized from the Salary Emergency fund.
- 4. That the attached 2024 Proposed Budget for the Presbytery of St. Andrew be adopted with the understanding that the Presbytery expects the committee to present a balanced 2025 budget without further expenditures of reserve funds.

The Presbytery then adjourned for lunch with prayer by Douglass Sullivan-Gonzalez at 12:07 p.m., after which it reconvened at 1:30 p.m. to complete its work.

The trailer for the documentary film, "At the River" was viewed, after which Frank Beck was recognized for the Commission on Ministry's report. He reported the following items for information:

- 1. Dr. Robert Green has been certified by the Commission as ready to be examined for commissioning, and that upon his commissioning he be granted all permissions of G-2.1001 and named moderator of the session at Aberdeen Presbyterian church.
- 2. The pastoral relationship between the Rev. Rob White and FPC, Hernando was dissolved effective August 20, 2023 and he was transferred to the Presbytery of Central Florida where he will be installed as the pastor of Eastminster Presbyterian Church of Indialantic, Florida.
- 3. Changes in terms of call were approved as follows:

4. The new requirements of G-3.0106 of the Book of Order were considered. That section now reads as follows:

All councils shall adopt and implement the following policies: a sexual misconduct policy, a harassment policy, a child and youth protection policy, and an antiracism policy. Each council's policy shall include requirements for boundary training which includes the topic of sexual misconduct, and child sexual abuse prevention training for its members at least every thirty-six months.

The Commission will develop the presbytery's new required harassment and antiracism policies, and a recommendation for how to fulfill the requirement of the presbytery as well as all sessions to provide boundary training for their members. Models for session policies will also be considered by the Commission in conversation with other presbytery committees.

The Rev. Thomas Groome was then presented for membership in the presbytery as a retired minister. He updated the presbytery on his service as an interim pastor to several congregations following his departure as Pastor of FPC, Tupelo, and was examined briefly on his Christian faith and his views in theology, worship and Sacraments, and polity, after when Rev. Back moved on behalf of the Commission that he be received back into the Presbytery's membership. The motion was adopted by raised hand vote.

Ruling Elder Dr. Robert Green was then presented and examined for commissioning to the Aberdeen Presbyterian Church. Rev. Beck then moved that the examination be sustained and that he be commissioned as pastor of Aberdeen Presbyterian Church with permission to administer Sacraments, and that he be named moderator of the session. The motion was adopted, after which Moderator Howie led the commissioning service.

Greg Goodwiller reported for the Governing Body Relations Committee and moved that minutes from the following sessions be approved without exception: FPC, Amory; Batesville; Benoit; Black Jack, Batesville; FPC, Columbus; FPC, Greenville; Leland; New Bethlehem; FPC, Pontotoc; Ripley; Starkville; Sumner, FPC, Oxford, FPC, Saltillo, and Bethany, Louisville. The motion was adopted by voice vote.

Nancy Bryson and B.J. Chain were then recognized for the report of the Committee on Thanks. They expressed their appreciation to the Presbytery and Camp Hopewell, along with various meeting participants for their hard work in preparing for and executing the meeting.

The meeting was then adjourned with prayer by Dan Rupert at 2:08 p.m.
